Instructions Memo

If you have received FPPA approval for a non-taxable (on-duty) disability retirement or survivor benefits, you are now eligible to receive the funds in your Separate Retirement Account (SRA).

Following this memorandum, you will find the forms necessary for distribution of funds. When all the necessary forms are returned, and after your final contribution is received, FPPA will begin processing your payments. If the disability or death has been determined by FPPA to be due to an on-the-job injury or condition, the SRA will be non-taxable.
