## **MODEL RESOLUTION**

### **INCLUSION OF CLERICAL AND OTHER PERSONNEL WHOSE SERVICES ARE AUXILIARY TO FIRE PROTECTION UNDER THE FPPA STATEWIDE DEFINED BENEFIT PLAN OR THE STATEWIDE MONEY PURCHASE PLAN**

(Note: The adopting entity should change “*Employer*” to the entity’s legal name and may adapt the model to follow its own format for resolutions.)

**WHEREAS**, *Employer* is a fire protection district, fire authority, or county improvement district providing fire protection services, duly constituted under Colorado law; and

**WHEREAS**, for the purposes of participation in the statewide defined benefit plan pursuant to part 4 of Title 31, Article 31, C.R.S. or participation in the statewide money purchase plan pursuant to part 5 of Title 31, Article 31, C.R.S. as operated by the Fire and Police Pension Association, pursuant to Section 31-31-102(4) C.R.S., the definition of “Member” may include clerical or other personnel employed by a fire protection district, fire authority, or county improvement district, whose services are auxiliary to fire protection.

*IF THE EMPLOYER’S FIREFIGHTERS PARTICIPATE IN THE DEFINED BENEFIT PLAN:*

**WHEREAS**, *Employer’s* full time active employees whose duties are directly involved with the provision of fire protection are covered under the statewide defined benefit plan established pursuant to part 4 of Title 31, Article 31 C.R.S. *Employer* desires to cover its clerical and other personnel working sixteen hundred hours or more per year under the statewide defined benefit plan established pursuant to part 4 of Title 31, Article 31, C.R.S. *Employer* further desires to cover its clerical and other personnel working less than sixteen hundred hours per year under the statewide money purchase plan established pursuant to part 5 of Title 31, Article 31, C.R.S. as is provided under Section 31-31-401 (5), C.R.S. *Employer* acknowledges that said clerical and other employees are not eligible to participate in the statewide death and disability plan established pursuant to part 8 of Title 31, Article 31, C.R.S.

*IF THE EMPLOYER’S FIREFIGHTERS PARTICIPATE IN THE MONEY PURCHASE PLAN:*

**WHEREAS**, *Employer’s* full time active employees whose duties are directly involved with the provision of fire protection are covered under the statewide money purchase plan established pursuant to part 5 of Title 31, Article 31 C.R.S. *Employer* desires to cover its clerical and other personnel under the statewide money purchase plan established pursuant

*IF THE EMPLOYER'S FIREFIGHTERS PARTICIPATE IN THE DEFINED BENEFIT PLAN:*

1. *Employer* does hereby elect to cover its clerical and other personnel working sixteen hundred hours or more per year under the statewide defined benefit plan established pursuant to part 4 of Title 31, Article 31, C.R.S. *Employer* further desires to cover its clerical and other personnel working less than sixteen hundred hours per year, if any, under the statewide money purchase plan established pursuant to part 5 of Title 31, Article 31, C.R.S. as is provided under Section 31-31-401 (5), C.R.S.

*IF THE EMPLOYER'S FIREFIGHTERS PARTICIPATE IN THE MONEY PURCHASE PLAN:*

1. *Employer* hereby elects to cover its clerical and other personnel under the statewide money purchase plan established pursuant to part 5 of Title 31, Article 31, C.R.S.

2. Such election shall become effective on \_\_\_\_\_, 20\_\_, assuming all necessary forms, procedures and other relevant work is completed; and

3. The *Employer's clerk or secretary* is directed to file a certified copy of this resolution with the Fire and Police Pension Association as soon as is practicable and *Employer's staff* is directed to take all other actions necessary to implement the coverage.
